School board races packed

Incumbents face challenges in 10 High Desert districts

The deadline for incumbents and challengers to file in November's general election has passed, and among contested political positions are seats within 10 local community college and school boards.

With the Nov. 8 election quickly approaching, the candidate lineup of Victor Valley and Barstow community college districts and eight High Desert K-12 school districts are a mix of familiar and fresh faces.

For the VVC Board of Trustees, incumbents Joseph W. Brady and John Pinkerton will vie for two available seats against four challengers: Thomas J. Kerman, a teacher; Davis "Wes" Gregg, an information systems technician; Bob Conaway and Margaret H. Kagy, a retired college employee.

Brady, who is president of The Bradco Companies, a commercial brokerage firm serving the High Desert region, has said running for his second term on VVC's board will also be his "last political run."

Pinkerton, who earlier this year ran in the primary for the 8th Congressional District, is also seeking his second term at VVC after most recently serving as the board president. He also works in Victorville as a counselor at Silverado High School.

Within BCC's board race are also two incumbents, Ted P. Baca and Fernando "Fred" Baca. They are joined in the race by finance manager Patricia Rosenberg, operations supervisor Elbert W. Muncy III and John D. Coffey.

Additional to the eight K-12 school districts with challenged seats are three districts with seats which incumbents will automatically fill, unchallenged. Apple Valley Unified School District has incumbents filling two seats while Oro Grande School District and Silver Valley Unified School District each have one.
